RE: FOIA Pre-Authorization Request - 2011 PAC 14413

Dear Mr. Fronczak:

We have received and reviewed the written notice from the Cook County Medical Examiner's Office (County) of its intention to deny disclosure of certain information pursuant to section 7(1)(c) of the Freedom of Information Act (FOIA) (5 ILCS 140/7(1)(c) (West 2009 Supp.), as amended by Public Act 96-1378, effective July 29, 2010).

On May 9, 2011, [REDACTED] submitted a FOIA request for all photographs pertaining to [REDACTED]. In its written notice, the County asserts that the requested information is exempt from disclosure under section 7(1)(c) of FOIA because the photographs depict the body of the decedent post-mortem.

Section 7(1)(c) of FOIA exempts from inspection and copying "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, unless the disclosure is consented to in writing by the individual subjects of the information." The exemption defines "unwarranted invasion of personal privacy" as "the disclosure of information that is highly personal or objectionable to a reasonable person and in which the subject's right to privacy outweighs any legitimate public interest in obtaining the information."

**DETERMINATION**


The County's use of the exemption in section 7(1)(c) to withhold photographs depicting the victim post-mortem is **approved**. Based on the County's representation, we conclude that release of these photographs would constitute a clearly unwarranted invasion of

personal privacy. This type of information is highly personal by its very nature and its release would be objectionable to a reasonable person.<sup>1</sup> As a result, the County has met its initial burden of demonstrating that the photographs are exempt from disclosure under section 7(1)(c) of FOIA.


