Dear Mr. Reuter,

We have received and reviewed the written notice from the Illinois Environmental Protection Agency (IEPA) of its intent to deny disclosure of three documents as exempt from disclosure under Section 7(1)(f) of the Freedom of Information Act. 5 ILCS 140/7(1)(f). This matter involves a FOIA request submitted by for records related to the National Castings facility in Melrose Park. The IEPA has asserted that a Treatment Storage Disposal (TSD) Initial Screening document and two Preliminary Assessment/Visual Site Inspection (PA/VSI) documents are exempt from disclosure under Section 7(1)(f).

Section 7(1)(f) of FOIA exempts from disclosure records that constitute "[p]reliminary drafts, notes, recommendations, memoranda and other records in which opinions are expressed, or policies or actions are formulated, except that a specific record shall not be exempt when the record is publicly cited and identified by the head of the public body."

Determination

IEPA's use of the Section 7(1)(f) exemption with respect to the documents in question is **approved**. IEPA has asserted that the documents are initial screening or preliminary assessment documents in which evaluators express opinions about environmental impact or whether corrective action is appropriate. The IEPA has also asserted that none of the documents has been publicly cited or identified by the IEPA's director. Thus, these documents are exempt from disclosure under Section 7(1)(f) of FOIA.
