RE: Pre-Authorization Request — 2010 PAC 9411

Dear Ms. Briggs:

We have received and reviewed the written notice from the Town of Normal (Town) of its intention to deny disclosure of certain information as exempt from disclosure under Section 7(1)(c) of the Freedom of Information Act (FOIA). 5 ILCS 140/1 *et seq.*, as amended.

██████████ submitted a FOIA request on August 27, 2010, seeking a copy of a police report concerning an accident which occurred on August 23, 2010, on Gregory Street at University High School. In its written notice, the Town asserted that dates of birth and information which references specific injuries to a driver, witness or passenger is exempt from disclosure under Section 7(1)(c) of FOIA.

Determinations

Section 7(1)(c) of FOIA exempts from inspection and copying "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, unless disclosure is consented to in writing by the individual subjects of the information." The exemption defines "[u]nwarranted invasion of personal privacy" as "the disclosure of information that is highly personal or objectionable to a reasonable person and in which the subject's right to privacy outweighs any legitimate public interest in obtaining the information." *Id.*

The Town's use of the exemption in Section 7(1)(c) with regard to dates of birth is approved. We have determined that the disclosure of dates of birth would constitute a clearly unwarranted invasion of personal privacy under Section 7(1)(c). 5 ILCS 140/7(1)(c). This type of

information is highly personal by its very nature and the subject's right to privacy outweighs any legitimate public interest in disclosing this information.

The Town's use of the exemption in Section 7(1)(c) with regard to injuries sustained as a result of this car accident is denied. The proposed redactions affect only general statements concerning reported injuries that may have occurred during this accident. The report discloses no detailed information regarding the precise nature of any medical condition, specific diagnoses or other sensitive matters. The Town has not met its burden of establishing that the disclosure of this information would constitute a clearly unwarranted invasion of personal privacy under Section 7(1)(c). 5 ILCS 140/7(1)(c).

As such, the Town may issue a partial denial letter directly to [REDACTED] and release the report to her with the appropriate information redacted.
