Dear Ms. Rohrer:

We recently received from the Boone County Sheriff's Office a written request for pre-approval of its intention to assert the Section 7(1)(c) exemption in response to a Freedom of Information Act request received from [REDACTED] dated November 24, 2010. [REDACTED] requested a copy of the full report and narrative from case 09-10000744.

Section 7(1)(c) of FOIA permits a public body to withhold "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy." That provision further defines an "unwarranted invasion of personal privacy" as "the disclosure of information that is highly personal or objectionable to a reasonable person and in which the subject's right to privacy outweighs any legitimate public interest in obtaining the information."


As a result of our review, we have determined that certain information from the report requested by [REDACTED] may be redacted pursuant to Section 7(1)(c) because disclosure would result in a clearly unwarranted invasion of the subject's personal privacy, but the report may not be withheld in its entirety. The information that may be redacted consists of the dispatcher's log entries and the narrative. We have enclosed a copy of the report to the Sheriff's Office with the approved redactions highlighted in yellow. The request to assert the exemption under Section 7(1)(c) is approved with regard to the above redactions, and further inquiry into this matter is not warranted.

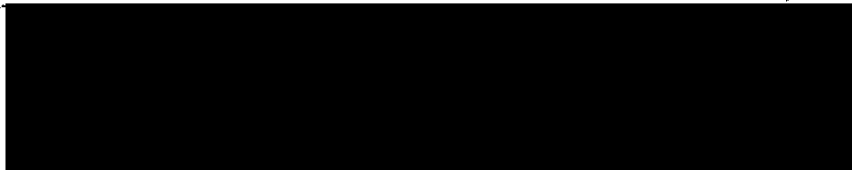
